Comments: Ms. Simpson informed the Board that this Resolution is related to the Yaffa Dirt Pile project. Remediation at the site has been ongoing since mid- 2022. Two piles (estimated 14,000 +/- tons) of contaminated soil material have been off loaded and disposed of at a regulated facility. Work is projected to start early October to address the remaining large pile (estimated at \$56,000+/- tons) of contaminated soil material. A Licensed Site Remediation Professional (LSRP) is required to oversee any environmental cleanup. The professional services agreement with the LSRP is required to be in place for the remaining remedial activities for the Yaffa Site. A cost proposal was solicited from Montrose, the LSRP of record,

The City has allocated \$5 million in American Rescue Plan (ARP) and Transitional Aid Fund for the removal of contaminated soil material at the Yaffa Site. CRA finds it necessary to amend the current agreement with Brownfield Redevelopment Solutions (BRS) to add additional grant requirements for the use of Supplemental Transitional Aid funds from the City and oversight during the removal process.
