Public Comments

Chairman Bowman asked for public comments at 6:02 PM.

Ms. LaVerne Williams of 218 Branch Village inquired about Resolution E. She asked "How much was the original contract?" And "Is the change order in compliance with the purchasing law? " Economic Development Director James Harveson confirmed the change order is in compliance with state law. Ms. Williams questioned the cause of the price increase. Mr. Harveson explained there was a change in specifications for park benches.

Regarding Resolution C, Ms. Williams inquired as to how long it will take for the title search to be completed. Housing Director Olivette Simpson explained the work has already been completed; the Resolution addresses a change in the amount for the closing..

Regarding Resolution B, Ms. Williams questioned for whom the training would be provided. Executive Director Johnson noted this Resolution pertains to a one-day retreat for staff.

Mr. Frank Fulbrook of 211 Penn Street asked for clarification on the design change of the park benches. Mr. Harveson explained the original plan called for monolithic concrete square benches. The new plan is to install decorative metal benches that matches the trashcan design with an arm in the middle to discourage sleeping. Mr. Fulbrook asked "how close is the project to completion?" Mr. Harveson informed that the project is 30% complete and the park will open before summer.

He also inquired about the status of the Pierre Building. Mr. Harveson reported an RFP had been issued that it is available on the CRA website. There has been considerable interest.

Mr. Colandus "Kelly" Francis of the NAACP reminded the Board of the civil and criminal liabilities of ownership of the properties at Lanning Square. Vice Chair Gloria Pena asked Mr. Francis to describe what the properties look like. He explained the homes were built without firewalls and most of the homes have been gutted. Vice Chair Pena advised that she would like to see what they look like.

Mr. Francis circulated an article concerning a recent fatal fire in Philadelphia. Commissioner Jose Vazquez noted the importance of firewalls running up to the roof. Vice Chair Pena stated the CRA should demonstrate a high regard for safety.

Chairman Bowman inquired about the plans for the CRA-owned properties at Lanning Square. Ms. Simpson explained: CRA insured the properties at the time of their acquisition. Negotiations are underway with a local non-profit organization pertaining to maintenance of the properties. Demolition(s) will be contingent upon the results of a structural report that will be commissioned sometime in the near future.

Vice Chair Pena wants to ensure the properties are properly secured until a final determination is made regarding the redevelopment of Lanning Square. Chairman Bowman inquired about whether or not fencing can be posted around the properties. Ms. Simpson reported the properties are not contiguous.

Director Johnson offered to forward photographs of the CRA-owned properties for the Board's review. Ms. Simpson will arrange a tour for Vice Chair Pena as well.

Mark Asselta recommended the structural assessment include a risk analysis.

Ms. Williams encouraged the Board to consider relocation of current residents prior to demolition and/or redevelopment activity.

Commissioner Louis Quinones questioned why residents are still living in the units when the Certificates of Occupancy were withdrawn sometime ago.

Mr. Francis speculated the occupants don't know their rights and added they were low-income homeowners. He noted the three inspectors who were responsible for detecting the fatal defect were prosecuted by the State; they were fined and forced to retire.
