Resolution Authorizing Acceptance of 24 Properties Located in the Parkside Redevelopment Area from the City of Camden for Residential Development

Project Summary:

- 1. The City of Camden seeks to transfer to CRA for nominal consideration 24 vacant, scattered site properties located within the Parkside Redevelopment Area to facilitate residential redevelopment in Parkside.
- 2. The City proposes that the CRA sell these properties to a qualified redeveloper(s) as the property sites are suitably located for development of new and rehabilitated housing for homeownership.
- 3. The City at its October 13, 2015 Meeting adopted an Ordinance for the transfer of 19 of the properties to CRA, and is in the process of enacting an Ordinance for the transfer of the remaining 5 properties. The properties are more fully described in Exhibit A attached. Sites are largely scattered along Park, Empire, Kenwood, and Princess Avenues.
- 4. The City's condition for transfer of these properties is that all proceeds from the sale of the properties by CRA to a developer will be distributed to the City.

Resolution Authorizing Acceptance of 24 Properties Located in the Parkside Redevelopment Area from the City of Camden for Residential Development

WHEREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the Council of the City of Camden (the "City Council") adopted, in accordance with the Local Redevelopment and Housing Law, 40A: 12A-1 et seq., ("LRHL"), an Ordinance effective June 2003, approving the Parkside Redevelopment Plan as to certain land within the City of Camden and more particularly described therein (the "Redevelopment Area"); and

WHEREAS, the City Council designated the CRA as the redevelopment entity pursuant to the LRHL to implement redevelopment plans and carry out redevelopment projects within the Redevelopment Area; and

WHEREAS, the City of Camden by an Ordinance adopted on October 13, 2015 and a second Ordinance proposed to be enacted, proposes to transfer to CRA 24 parcels located within Tax Blocks 1289, 1287, 1286, 1288, 1270, 1273, 1267, 1284, 1295, 1294, 1298, and 1300, set forth and more fully described within Exhibit A attached (the "City Parcels"); and

WHEREAS, the City proposes that the City Parcels be sold by the CRA to a qualified developer(s) for the proposed future land use of new construction and rehabilitation of residential dwelling units for homeownership, and

WHEREAS, City's condition for the transfer of the City Parcels to CRA is that the proceeds from the sale of the City Parcels to a developer(s) are to be distributed to the City; and

WHEREAS, CRA desires to accept the transfer of the City Parcels to further redevelopment in the Redevelopment Area.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency, that the Executive Director, a duly authorized representative of the Agency, upon adoption by the City of Camden of the Ordinances authorizing the transfer to the CRA, is authorized and directed, to accept conveyance of twenty-four (24) parcels described in Exhibit A for nominal consideration and subject to the terms and conditions set forth above; and

BE IT FURTHER RESOLVED, that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
