WHEREAS, the CRA desires to execute a professional services contract with the firm of Brown & Connery, LLP to provide General Counsel Legal Services at the hourly rates submitted in their proposal with a contract expiration date of January 31, 2019; and

WHEREAS, pursuant to the Local Public Contract Law N.J.S.A. 40A 11-5 ((1) (a)(i) this agreement is awarded without competitive bidding as a professional services contract.




