WHEREAS, the City of Camden Redevelopment Agency (CRA) is the owner of the property located at 100 Cooper Street and designated as Block 72 Lot 1 on the City of Camden Tax Map; and

WHEREAS, in the interest of public safety, the CRA has maintained a construction fence around the building; and

WHEREAS, the current service agreement with the vendor, Federal Rent A Fence has expired and it is the best interest of the CRA and the public to enter into a new service agreement with the vendor; and

WHEREAS, the current vendor has a proposed a cost of \$1,200.00 to continue to provide the construction fence for an additional period of one year; and

WHEREAS, the fence rental is an eligible cost under the US Environmental Protection Agency (EPA) Brownfields Cleanup Grant awarded for the building.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency, that the Interim Executive Director, a duly authorized representative of the Agency, is hereby authorized and directed to enter into an Agreement with Federal Rent A Fence to provide construction fencing at 100 Cooper Street for an amount not to exceed \$1,200.00 for an additional one year period; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
