Comments: Ms. Olivette Simpson, Interim Executive Director reported that the Housing Authority of the City of Camden (HACC) will make a presentation to the board regarding the Transformation Plan and \$35M Implementation grant. CRA was invited to participate as the Lead Neighborhood Implementation Entity. Commissioner Bowman asked that the record reflect this support for the HACC's efforts with Community Engagement and Job Creation. Ms. Simpson added there will be 25 Homeownership units as part of the plan. The application must be submitted by November 4, 2019.

Redevelopment Project Presentations

Executive Director Victor Figueroa, Erin Swlewski, Nick Cangelosi, and Tracey Powell, spoke to the intention of the initiative and noted as part of the Cramer Hill HUD Choice Neighborhoods Implementation Grant Application, the HACC in partnership with Michaels Organization will build a quality affordable age-targeted development on the vacant parcel with the address NS Harrison 24th to 25th Street, Block 814, currently owned by the CRA.

The approximately 65-unit age-targeted affordable rental community will be a stand-alone, surface parked, 3 to 4 story multifamily building. The development will be funded with a construction

loan from TD Bank, a permanent loan from NJHMFA, a portion of the Choice Neighborhood Implementation Grant and equity derived from the syndication of 9% low-income housing tax credits through Riverside Capital.

The Housing Plan is the result of a tremendous amount of community engagement that started with the award of Choice Neighborhoods Planning Grant in 2018. The grant has allowed for Ablett Village residents to meet with City Stakeholders and institutional partners, who together have worked towards planning the redevelopment of Ablett Village in context of a broader neighborhood transformation.
