Resolution Ratifying a Memorandum of Agreement and Authorizing a Collective Bargaining Agreement with the United Food and Commercial Workers Union Local 1360 (now Local 360) (now Local 360), Representing the Administrative Staff of the City of Camden Redevelopment Agency

WHEREAS, the Administrative employees of the City of Camden Redevelopment Agency ("CRA") are a collective bargaining unit of the CRA; and

WHEREAS, the CRA has engaged in negotiations with the authorized collective bargaining representative for the Administrative unit, the United Food and Commercial Works Union, Local 1360 (now Local 360) (now Local 360) ("UFCW"), and

WHEREAS, the CRA and UFCW have tentatively reached a settlement on all negotiable issues; and

WHEREAS, the parties have incorporated these tentative agreements into a Memorandum of Agreement (attached hereto as "Exhibit A") which is not binding on the CRA unless ratified by the CRA Board; and

WHEREAS, both the CRA and UFCW negotiating terms are recommending the successor Collective Bargaining Agreement be executed and implemented as soon as possible based upon the terms of the Memorandum of Agreement; and

WHEREAS, the CRA finds the terms of the Memorandum of Agreement to be reasonable and consistent with similar collective bargaining agreements entered into with the CRA; and

NOW THEREFORE, BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency that the Memorandum of Agreement attached hereto is hereby ratified and approved.

BE IT FURTHER RESOLVED, that the Interim Executive Director of the Agency, a duly authorized representative of the City of Camden Redevelopment Agency is hereby authorized to enter into a Collective Bargaining Agreement with the United Food and Commercial Workers Union, Local 1360 (now Local 360) (now Local 360) which includes the terms set forth in the attached Memorandum of Agreement; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.

Rank and File Unit

1. Revise language to reflect the change of UFCW Local 1360 to UFCW Local 360.

2. **ARTICLE XXVI – SALARIES**

Modify to read:

- A. Effective January 1, 2018, all employees shall receive a one and a half (1.5%) percent increase to their salaries.
- B. Effective January 1, 2019, all employees shall receive a one and a half (1.5%) percent increase to their salaries.
- C. Effective January 1, 2020, all employees shall receive a one and a half (1.5%) percent increase to their salaries.
- D. Effective January 1, 2021, all employees shall receive a one and a half (1.5%) percent increase to their salaries.

Retro Pay:

All employees shall receive full retro pay back to January 1, 2018 for all hours paid. On or before September 15, 2020, the Employer agrees to pay retro pay in a separate check.


3. **ARTICLE XXIV – DURATION OF AGREEMENT**


January 1, 2018 – December 31, 2021
