WHEREAS, the correct Tax Map designation for the Dominick Andujar Park site is Block 12, Lots 1, 3-9, 18-21 and Block 14, Lots 29-35 and 37 of the City of Camden Tax Map; and

NOW THEREFORE BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency, that Resolution 10-14-20F is hereby amended to correct the Tax Map designation of the Dominick Andujar Park site to Block 12, Lots 1, 3-9, 18-21 and Block 14, Lots 29-35 and 37 of the City of Camden Tax Map

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the New Jersey Economic Development Authority; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all grant documents, grant agreements and grant reports necessary to secure and administer the Grant and to carry out the purposes of this resolution.
