Resolution Amending Resolution 10-14-20G Which Authorized an Application for and Acceptance of a Grant from the New Jersey Hazardous Discharge Site Remediation Fund in an Amount Not to Exceed \$195,562 for Remedial Action at the Dominick Andujar Park By Correcting an Error in the Tax Map Block and Lot Designation of the Park Site

Project Summary:

- The CRA by Resolution 10-14-20G authorized an Application for and Acceptance of a Grant from the New Jersey Hazardous Discharge Site Remediation Fund in an amount not to exceed \$195,562 for remedial action at Dominick Andujar Park.
- In Resolution 10-14-20G the Tax Map designation for the Dominick Andujar Park site was indicated as Block 12, Lots 1-9 and Lots 17-21, Block 14, Lots 24, 29-35 and 27 of the City of Camden Tax Map.
- This Resolution is to correct the error to the Tax Map designation for the Dominick Andujar Park site. The Park is designated as **Block 12, Lots 1, 3-9, 18-21 and Block 14, Lots 29-35, 37** of the City of Camden Tax Map.

WHEREAS, the City of Camden Redevelopment Agency (“CRA”) by Resolution 10-14-20G authorized an Application for and Acceptance of a Grant from the New Jersey Hazardous Discharge Site Remediation Fund in an amount not to exceed \$195,562 for a Remedial Action at Dominick Andujar Park; and

WHEREAS, Resolution 10-14-20G incorrectly referenced the Tax Map designation for the Dominick Andujar Park site as Block 12, Lots 1-9 and Lots 17-21, Block 14, Lots 24, 29-35 and 27 of the City of Camden Tax Map; and

WHEREAS, the correct Tax Map designation for the Dominick Andujar Park site is Block 12, Lots 1, 3-9, 18-21 and Block 14, Lots 29-35 and 37 of the City of Camden Tax Map; and

NOW THEREFORE BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency, that Resolution 10-14-20G is hereby amended to correct the Tax Map designation of the Dominick Andujar Park site to Block 12, Lots 1, 3-9, 18-21 and Block 14, Lots 29-35 and 37 of the City of Camden Tax Map

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the New Jersey Economic Development Authority; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all grant documents, grant agreements and grant reports necessary to secure and administer the Grant and to carry out the purposes of this resolution.
